

SUMMARY ANNUAL REPORT

For Cornell College Tax Deferred Annuity Plan

This is a summary of the annual report for Cornell College Tax Deferred Annuity Plan, EIN 42-0680335, Plan No. 002, for period January 01, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$385,844. These expenses included \$385,844 in benefits paid to participants and beneficiaries, and \$10,206,158 in net transfers to other plans. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of December 31, 2015, compared to \$9,952,494 as of January 01, 2015. During the plan year the plan experienced a decrease in its net assets of \$9,952,494. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$639,508, including employee contributions of \$311,280, other contributions of \$163,418 and earnings from investments of \$164,810

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Vernon, IA 52314) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
