Off-Campus Housing Lottery
Group Form

Eligible students signing up for the lottery have the choice of signing up as an individual or as a group. If you are drawing as a group, read the following, decide on a member of your group to draw the number for the group, and sign below to indicate understanding of the process.

Those students approved for off-campus living through the off-campus lottery are committed to this assignment unless they have communicated with the Office of Residence Life in writing by March 1, 2025. Students who decline their off-campus assignment after the March 1st deadline will be required to participate in Late Numbers Draw. Students participating in late draw may not select a room, NOR MAY THEIR ROOMMATE(S) SELECT A ROOM, until all other students have selected a room.

Students living off campus through the off-campus lottery have the option to choose 7 meals per week (and may also choose the 14 meals per week or 20 meals per week option). The meal plan information on this form is only valid if the corresponding student is able to be granted off-campus approval through the lottery (any student not granted off-campus approval will be subject to the meal plan expectations of whatever housing assignment they do get). Students who select a "full" meal plan will make their specific meal plan preference (between the 14 or 20 meals per week) over the summer.

Requirements to draw as a group:

- a) Only one number will be drawn for the group.
- b) The members of the group must decide who will draw the number and sign a waiver giving permission to that group member to draw the group's number.
- c) Depending on the number drawn, all those signing up together as a group will be either granted or denied permission to live off-campus.
- d) All members of the group must be present at the time a number is drawn, or have signed and returned this form to the residence life office prior to a number being drawn for the group.
- e) No more than four (4) eligible students per group.
