What Is a Young Trustee?

A Young Trustee is a **full voting member** of Cornell's Board of Trustees who brings a recent-student perspective into Board discussions.

- ✨ No prior board experience required
- ✨ You're *not* expected to have all the answers or agree with everyone all the time
- ✨ You *are* expected to show up curious, prepared, and engaged

Why This Is a Big Deal

As a Young Trustee, you will:

- ✓ Learn how nonprofit boards really work
- ✓ Participate in high-level decision-making
- ✓ Build leadership and strategic thinking skills
- ✓ Network with alumni and professionals across industries
- ✓ Stay meaningfully connected to Cornell after graduation

Time Commitment

Term: Spring 2026 – Spring 2029

Meetings: Three per year (Fall, Winter, Spring), all on campus

- ★ Often align with **Homecoming** and **Commencement**
- ★ Trustees are expected to review materials in advance
- ★ Attend **at least 50% of meetings** over 3 years

 Travel (within the continental United States), lodging, and meals for official meetings are covered by the College.

Support Along the Way

You won't be thrown into the deep end.

- Formal onboarding sessions during your first year
- Ongoing support from staff and fellow Trustees

You'll learn as you go — that's the point.

- March-April: Make your appointment at the [Dungy Writing Studio](#) to consult on your personal statement (required), consult [Berry Career Institute](#) for application feedback (required)
- April 20: 1 Letter of Recommendation from faculty/staff and 1 Letter of Recommendation from a peer **due via email** to RuthAnn Scheer rscheer@cornellcollege.edu (required)
- April 20: Applications **close. Submit application to rscheer@cornellcollege.edu**
- May 7: Interviews **on campus** with the Board's Young Trustee Selection Committee

One member of the Class of 2026 will be recommended by the Board's Governance Committee and elected by the Board of Trustees.
